Introduction

The appearance of under eye bags and dark circles are the main result of the aging process, which includes collagen degradation. This process results in thinner, more translucent skin below the eyes, which accentuates the appearance skin vasculature. The goal of diminishing under eye bags and dark circles is to reduce puffiness and inflammation by vasoconstriction of the capillaries. Vasoconstriction decreases the size of the blood vessels around the eyes thus masking the degradation of collagen and giving a more youthful appearance.

Materials & Methods

An *in-vivo* study was conducted over a period of three weeks to evaluate the effect of **Revital-Eyes** on under eye bags and dark circles. 10 M/F subjects between the ages of 23-45 participated in the study. Results indicate that this material is capable of significantly decreasing the appearance of under eye bags and dark circles.

Following initial measurements, all subjects were asked to apply a 5% solution of **Revital-Eyes** to the right periorbital area twice a day for three weeks. Photographs were taken immediately after application of test materials and then weekly for three weeks.

Results

Revital-Eyes is capable of significantly reducing the appearance of under eye bags and dark circles at the conclusion of the study. In addition, wrinkles and expression lines were also diminished with consistent product use.




Figure 1: Before and after pictures of subject #1 following application of a Revital-Eyes solution.
