

### AC Party Face Pom Increase in Skin Smoothness

#### **Abstract**

The purpose of this study is to determine the in vivo effectiveness of **AC Party Face Pom 4%** on skin smoothing properties. Our technical staff conducted a series of tests to determine the efficacy on 15 volunteers between the ages of 36 and 65. **AC Party Face Pom 4%** was compared to a control, and the results showed that **AC Party Face Pom 4%** is effective at increasing skin smoothness.

#### **Materials and Methods**

For surface area, we examined a 1cm2 field on the volunteers' forearms. One forearm was treated with the **AC Party Face Pom 4%** while the other arm was treated with a placebo. Products were applied twice daily for 30 days. Silicon polymer casts were made before and after product application and the smoothing effect was observed with a profilometer equipped with an image analyzer. Illumination cast at a 35° angle forms shadows on the casts, and the analyses of gray levels were analyzed via a software program on a computer to determine skin smoothness.



#### **Discussion**

After twice daily application for 30 days, there was significant increase in skin smoothness. Skin smoothness increased by 12.9%, whereas the placebo only increased by 6.7%. This leads us to believe that **AC Party Face Pom 4%** is sufficient at increasing skin smoothness.
